NATIONAL COMMISSION FOR SCHEDULED TRIBES NCST/ATY-204/TS/9/2022-APCR

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of President, Telangana ST Employees Welfare Association, Hyderabad regarding burning of huts of 40 ST families in Chadarghat, Hyderabad and due compensation by local administration.

Date of the Sitting: 26/03/2025, 10:40AM Participants in the Sitting: As per Annexure

A representation dated 02.01.2022 was received in the Commission from Shri M Mallaiah, President, Telangana ST Employees Welfare Association, Telangana. He alleged that on 31.12.2021, some anti-social elements have burnt 40 huts of tribal people at Chadarghat, Hyderabad. Due to this, the victim ST families become homeless and they have no livelihood source. The petitioner has requested the Commission to issue necessary directions for action taken against accused, rehabilitation of victim ST families, compensation and providing residential and agriculture land. He requested the Commission to intervene in the matter.

- 2. In this matter, the Commission has held sittings earlier on 10.02.2022, 22.08.2024 and 15.10.2024. In the last sitting held on 15.10.2024, the following recommendations were made and the minutes were forwarded on 21.11.2024.
- "All the recommendations of the Commission made during the earlier sitting held on 22.08.2024 and communicated vide minutes dated 02.09.2024 to be complied.
- The District Collector shall attend to the next scheduled date of Hearing.
- Report in this regard to be submitted to the NCST within 30 days time-frame."
 - 3. The Collector & District Magistrate, Hyderabad District, vide his letter no. C.2/NCST/116/2022 dated 09-12-2024 has requested the Chief Secretary, Telangana Government for providing funds for payment to the effected ST families. He urged immediate fund allocation and submission of a compliance report to NCST before the next hearing. Further, the Collector and District Magistrate, Hyderabad, vide his letter no. C.2/NCST/116/2022 dated 27.02.2025, has informed NCST that the Commission had recommended enhancing compensation from ₹6,000 to ₹3-5 lakh per affected family, allotting pucca houses, and submitting a detailed list of affected parties with awarded compensation. This requires funds and the Chief Secretary, Telangana, was requested to arrange funds, but it has not been sanctioned. The Revenue Divisional Officer reported that 20 huts were burned, affecting 12 ST, 3 SC and 5 BC families. Out of 12 ST families, 10 have received houses in Bandlaguda Mandal and 2 have been sanctioned 2BHK houses as per NCST's orders.
 - 4. The Commission decided to discuss the issue with the authority and the petitioner on 26.03.2025. Accordingly, a Sitting Notice was sent on 12.03.2025.
 - 5. In the sitting, Collector & District Magistrate, Hyderabad and petitioner were present. Collector & District Magistrate, Hyderabad has reiterated its earlier submission and stated that Govt. of Telangana requested to release Additional Budget to pay the compensation to pay the ST affected families as directed by NCST. After receipt of the Budget the same will be disbursed to ST affected families.
 - 6. After discussion with the Collector & District Magistrate, Hyderabad and petitioner, the following recommendations were made and action taken there on may be submitted to NCST within 30 days.
- The Chief Secretary, Govt. of Telangana is advised to consider for release Additional Budget to pay the compensation to ST affected families, as requested by Collector and District Magistrate, Hyderabad.
- The Commissioner, Tribal Welfare may examine and consider to provide loan and subsidy through ST Finance Corportaion (TRICOR) to facilitate to establish a viable unit for the livelihood of the affected ST families.

The District Collector may coordinate with the Commissioner, Tribal Welfare accordingly.
