

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi regarding illegally killing or removing or shifting of pigs by the authorities of all Municipalities, Nagar Panchayats, Municipal Corporation and Gram Panchayats in the State of Telangana by violating Hon'ble High Court judgment.

Date of the Sitting: 26/03/2025, 12:00 (Noon)

Shri M. Mallaiah, Hyderabad has submitted a representation dated 03.08.2020 regarding illegally killing or removing or shifting of pigs by the authorities of all Municipalities, Nagar Panchayats, Municipal Corporation and Gram Panchayats in the State of Telangana by violating Hon'ble High Court judgment.

2. He stated that most population of the Scheduled Tribes in the State of Telangana and Andhra Pradesh especially Yerukulas are in pig rearing profession and the family members of the STs are financially dependent in such profession. Recently, the State Govt. authorities took action to kill or remove or shift the pigs from the ST Habitations and Hosueholds premises. There by causing irreparable financial losses. Earlier, the Hon'ble High Court of AP has given directions to the State Govt. to provide land and infrastructure along with pig rearing license to the pig owners. But, this order has not been implemented. The petitioner has requested to implement the Hon'ble High Court order given in 1986.

3. The NCST vide letter dated 7.1.2021 has referred the matter to Principal Secretary, MA&UD, Govt. of AP and Principal Secretary, MA&UD, Govt. of Telangana for facts and comments. The reply was not received from the concerned authorities, hence, NCST has decided to discuss the issue with concerned authorities and petitioner on 26.3.2025. Accordingly, a sitting notice was issued on 18.3.2025.

4. The Principal Secretary, MA&UD, Govt. of AP vide letter dated 21.3.2025 has sought exemption and deputed Joint Director, Municipal Administration to attend the sitting. Principal Secretary, MA&UD, Govt. of Telangana vide letter dated 25.3.2025 has sought exemption and deputed Chief Veterinary Officer, Greater Hyderabad Municipal Corporation, Hyderabad to attend the sitting.

5. In the sitting, the above officers and petitioner were present. The petitioner reiterated their submission and requested for justice. The officer of Govt. Andhra Pradesh submitted the letter dated 25.3.2025 of Commissioner and Director, Municipal Administration, Govt. of Andhra Pradesh, Guntur District which contains the action taken by the Govt. of Andhra Pradesh in the matter. The Govt. of Andhra Pradesh has issued the Guidelines in April, 2017 to tackle the problems of pigs and to set out the time frame to take action in the matter. The officers of Govt. of Telangana also informed about the provisions meant for the protection of pigs and action taken by the Urban Local Bodies of the State have also been submitted.

6. After discussion with the concerned authorities and petitioner, the following recommendations were made and action taken there on may be submitted within 30 days from receipt of the minutes.

- a. The State of Telangana may issue a GO in the lines of Government of AP to protect the interests of the ST community dependent on piggery for livelihood.
- b. The Departments of MA&UD, Animal Husbandry and Tribal Welfare Departments may take necessary action to form Pig rearing societies and for supporting them.
- c. The Yerukula Empowerment scheme launched by Government of Telangana may be supported from ST Finance corporation TRICOR
- d. Principal Secretary, MA&UD, Secretary, Animal Husbandry and Secretary, Tribal Welfare Department may attend to the next scheduled date of hearing with complete details.
