Minutes of the Sitting held on 11.12.2024 at 04:20 P.M. under the Shri Tatothu of Hussain, Hon'ble NCST regarding Suo-moto cognizance of the Commission on the News Item dated 04.09.2024 published in the local newspaper in respect of physical assault and attempted rape on a tribal Woman.

Date of the Sitting : 11.12.2024 at 04:20 P.M.

The Commission has taken suo-moto cognizance of a news clipping caption as "Tension in Jainoor, tribals torch vehicles". In this news it is mentioned that an auto driver raped an ST women and tried to kill her, while she was going to her parent's home in his auto. Considering seriousness of the case it has been decided to issue notices to the Director General of Police, Telangana, Collector & District Magistrate, Kumram Bheem Asifabad, and also to the Superintendent of Police, Kumuram Bheem Asifabad seeking factual report in the matter within a period of 03 days.

The Commission has sought a report within 3 days from the District Collector & Magistrate, Asifabad, DG, Police, Telangana and Superintendent of Police, Asifabad vide Notice dated 17.09.2024. The NCST has not received any reply from the concerned Departments. Considering the seriousness of the matter, the commission has decided to fix a sitting on 11.12.2024 at 04:20 P.M. and issue a Sitting Notice in this matter. Accordingly, the sitting notice was issued to the Director General of Police, Collector and District Magistrate and Superintendent of Police, District-KumuramBheemAsifabad, Telangana.

The District Collector, District-KumuramBheemAsifabad, Telangana vide letter no. C1/820/2024 dated 10.12.2024 has stated that Assembly sessions are commenced from 9th December, 2024 and frequently LAQs has been seeking from the Assembly and the Government flagship programmes are like Socio, Economic, Education, Employment, Political and castes survey and IndrammaIndlu applicants verification are going on top priority for which the presence of the Collector is essential at Head Quarters. Hence, the District Collector requested for exemption from the Sitting.

The Superintendent of Police, District-Kumuram Bheem Asifabad vide Memo No. 50/G1/2024 dated 10.12.2024 has directed to Sri A. Karunakar, SDPO, Asifabad and Sri B. Swamy, CI of Police, Rebbena Circle to attend the sitting on 11.12.2024 at 04:20 P.M. on behalf of Hon'ble DGP, Telangana, Hyderabad and SP, District-Kumuram Bheem Asifabad.

In this regard, the sitting was held on 11.12.2024 at 04:20 P.M. Sri A. Karunakar, SDPO, Asifabad and Sri B. Swamy, CI of Police, Rebbena Circle were present on behalf of Hon'ble DGP, Telangana, Hyderabad and SP, District-KumuramBheemAsifabad. They have submitted an Action Taken Report received from Superintendent of Police District-Kumuram Bheem Asifabad in which it has been mentioned that The Government has sanctioned the first stage of victim compensation of Rs. 1,00,000/- vide proc. No. C2/838/2024 dated 10.09.2024 U/Sec.3(2)(v) of SCs/STs (PoA) Act, 1989 and the amount has been credited in the account of the victim through PFMS portal payment advice No. A092416655445 dated 12.09.2024 and she has been provided employment on outsourcing basis by PO, ITDA, Utnoor vide proceeding no. NF No. T1/532/2024. Considering the heinous offence of attempt to commit sexual assault and attempt to murder the victim tribal woman, a proposal was sent to the District Collector to impose P.D. Act against the accused. Accordingly, P.D. Act detention orders were issued by the District Collector, KBM Asifabad vide Rc.C1/909/2024, dated

28.10.2024 and the accused was detained from 29.10.2024 vide G.O. Rt. No. 1462 dated 02.11.2024. Further, the Government confirmed the order of Detention G.O. Rt. No. 1598 dated 03.12.20204, GA(SPL-L&O) Dept. TG against the accused and ordered that the accused / detenue be continued for a period of 12 months from the date of detenue's detention i.e. 29.10.2024.

Discussion: The Hon'ble Member, NCST suggested that after intervention of the Commission the victim got the employment and the monitory relief as per the provisions and accused was detained.

Recommendations:

any such Necessary mechanism may be devised to avoid incidents/atrocities on STs and women in future.

It is observed that the Relief/compensation to the victims under SCs/STs (PoA) Act, 1989 is often delayed and is pending to be issued in many Districts. Necessary budget provision may be made and all the victims may immediately be given Relief on time as per the existing rules.

The abstract of details of the Atrocity cases pertaining to STs as on date from last 5 years and the relief provided to them and pendency status may be submitted to NCST in 15 days.
