Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Sri Badavath Arun, Village-Srinagar, Tukkuguda Municipality, District- Ranga Reddy, Telangana regarding communal remarks and threats.

Date of the Sitting: 10/02/2025, 12:20PM Participants in the Sitting: As per Annexure

Sri Badavath Arun, Village-Srinagar, Tukkuguda Municipality, District- Ranga Reddy, Telangana, a student of the 8th standard at ZPHS Boys School, Tukkuguda, Rangareddy District, Telangana, has alleged that the School Headmaster, Sri Kambalapalli Ramulu, made adverse remarks about his religious practices and threatened to issue him a Transfer Certificate (TC).

- 2. NCST vide Notice dated 21.01.2025 had referred the matter to the Director of School Education, Hyderabad and Commissioner of Police, Hyderabad for seeking facts and comments within 7 days. The reply was not received from the authority. Hence, NCST decided to discuss the issue with the authority and the petitioner on 10.02.2025. Accordingly, a Sitting Notice was sent on 31.01.2025.
- 4. The Commissioner of Police, Hyderabad vide letter no. 06/C6/NCST/RCK/2025 dated 06.2.2025 had submitted the facts and comment and stated that the matter is under investigation. The Director School Education, Hyderabad vide letter dated 08.2.2025 has also informed the facts and comments.
- 5. In the sitting the District Education Officer, Rangareddy appeared on behalf of Director School Education, Govt. of Telangana has informed that the Director, School Education has a prescheduled personal appearance at Hon'ble High Court of Telangana and hence could not appear for the hearing. ACP, Maheshwaram appeared on behalf of Commissioner of Police, Hyderabad. The petitioner has joined through phone.
- 6. The authority has informed Headmaster has been transferred and the enquiry process is in progress.
- 7. After discussion with the concerned authority and petitioner, the following recommendations were made and the action taken report may be submitted within 30 days from the receipt of the minutes.
- a. The Police Department may close the Cases filed on the other villagers who are not related to the incident.
- b. Disciplinary action may be taken on the Headmaster concerned.
- c. Steps may be taken to inculcate the mutual respect of religious sentiments and foster unity among the student and teachers community.

d. The Director, School Education may attend on the next scheduled date of hearing.
