Agenda Item No – 120.01 Inclusion of Tamaria/Tamadia community as synonym of Munda in the list of STs of Jharkhand.

The Ministry of Tribal Affairs has vide their letter No.12016/11/2001-C&LM.I dated 26th September, 2019, has sought the Comments of the National Commission for Scheduled Tribes on the proposal for inclusion of Tamaria/Tamadia community as synonym of "Munda" in the list of Scheduled Tribes of Jharkhand. In this context, the Ministry of Tribal Affairs has forwarded the study report by Dr. Ramdayal Munda Tribal Welfare Research Institute received from the Government of Jharkhand. The Ministry of Tribal Affairs has also forwarded the comments of the Registrar General of India.

This matter was earlier considered in the 116th meeting of the National Commission for Scheduled Tribes held on 18th June, 2019. In that meeting, the Commission was observed that the proposal was not in accordance with the prescribed guidelines for inclusion of a community in the ST list. Accordingly, the Commission recommended that the Ministry may first convey their decision in the proposal and thereafter refer to NCST along with views/comments of Registrar General of India.

Now in their comment, dated 25-09-2019 the Office of the Registrar General of India has duly supported the Jharkhand Government's proposal for inclusion of Tamaria/Tamadia as synonym of Munda, a ST in the State.

In view of latest comments of the Registrar General of India, the matter is put up before the Commission for consideration.

Agenda Item Proposal for inclusion of 'Yobin Tribe' in the Scheduled No – 120.02 Tribes list in the State of Arunachal Pradesh.

Ministry of Tribal Affairs has forwarded a copy of O.M. No.15025/02/2013-C&LM-1 dated October, 2018, forwarded a Proposal this received from the govt. of Arunachal Pradesh regarding inclusion of Yobin tribe in this list of Scheduled Tribe Arunachal Pradesh.

- 2. In this context, Ministry has stated that the proposal was sent to the Commission earlier for comments. The Commission had discussed the matter in its 60th meeting held on 25.08.2014 and comments was conveyed to the Ministry vide the Commission's letter dated 26.09.2014 and Commission has also reiterated this in its meeting dated 25.03.2018. The observation/comments of NCST were referred to the Government of Arunachal Pradesh vide Ministry's letter 14.10.2014. Government of Arunachal Pradesh notifying "Yobin Tribe" residing in Vijayanagar circle under Changlang District in Arunachal Pradesh. MoTA requested to State Government for withdrawal/cancellation of the notification and also sought comprehensive proposal for inclusion of Yobin Tribe.
- 3. Ministry of Tribal Affairs then sought the views of the Department of Legal Affairs on the issue of proposal for inclusion of "Yobin" tribe. It is noted 16 tribes are enumerated, however, Yobin tribe does not figure in these 16 tribes. The Ministry of Tribal Affairs advised the State Government to extend benefits/caste certificate etc. to Yobin tribe or any other indigenous tribe.
- 4. The advisory was issued to the State Government on the advice of Department of Legal Affairs. It was also stated that any doubt about this community, then a proposal would be require to be formulated based on the ethnographic study. However, Government of Arunachal Pradesh has again requested for inclusion of Yobin tribe in the ST list of State of Arunachal Pradesh. Ministry has also intimated that RGI has already conveyed its concurrence for inclusion of Yobin tribe in the ST list of Arunachal Pradesh.

Agenda Item Ban on single use of Plastic in National Commission for No – 120.03 Scheduled Tribes.

Accordingly, the following measures are proposed.

- Stop use of plastic bottles in meetings. Only glass/copper bottles are to be used in office and in meetings.
- Total ban on purchase of plastic folders, bags, file covers, etc.
- Ban on Plastic/thermocol cups, Plats, cutleries, decorative items, souvenirs.
- Ban on use of plastic/flex banners, posters and signages.

It is felt that all the employees of the Commission should also be encouraged to follow these green good practices.
