DOPT that the instructions on the pay and allowances admissible for the staff engaged on co-terminus basis in the personal section of Ministers, is applicable for the persons appointed as PS/APS/PA with Chairperson, Vice-Chairpersons, Members of NCST during their tenure, NCST, may, therefore, regulate the pay and allowances of such staff in accordance with the guidelines of DoPT issued for the persons engaged on co-terminus basis in the personal section of Ministers.
