Sub: Summary record of the 17th meeting of the National Commission for Scheduled Tribes held at 11:00 AM on 05/02/2010.

The 17th meeting of the National Commission for Scheduled Tribes was held at 11:00 AM on 05/02/2010 in the Conference room of the Commission in Lok Nayak Bhawan New Delhi. Consequent upon vacancy in the post of Chairperson in the Commission, the meeting was presided over by Shri Maurice Kujur, Hon'ble Vice-Chairman, as provided in the Rules of Procedure of the National Commission for Scheduled Tribes. List of participants is enclosed at ANNEXURE.

2. The Agenda of the meeting was to consider and finalize the revised draft of the 3rd Report of the Commission for the year 2007-08. The revised draft Chapters of the 3rd Report were circulated vide letter No. 4/7/09-Coord. dated 09/12/2009. Summary record of the discussions held in the meeting is given below:

Agenda To consider and finalise the revised draft Chapters of 3rd Report of the Item I NCST for the period 2007-08.

The Secretary, NCST informed that suggestions for certain amendments/ revision in the revised draft Chapters had been received from the office of the Chairperson and on the basis of those suggestions, all the Chapters have been further revised. Secretary listed the following follow-up action in respect of the draft Report:

- (i) Typing accuracies be checked once again in each Chapter
- (ii) It be checked that the Data given in each Table/ Annexure has been defined clearly.
- (iii) The format and page set up of each Chapter be re-set, in the presentable common format.
- (iv) Recommendations made at various places in each Chapter of the Report be copied and incorporated in the last Chapter on Summary of Recommendations. Proper referencing to each recommendation w.r.t. the particular para in the concerned Chapter, be made in this Chapter
- (v) Content page be prepared in the same format as was prepared for the 1st and 2nd Report.
- (vi) At present, the Chapter on SERVICE SAFEGUARDS does not include any specific recommendations. The Commission has made important suggestions/ recommendations in the SERVICE SAFEGUARDS Chapter of 2nd Report; and the Commission is not aware about the action taken on those recommendations by the Government. Therefore, those suggestions/ recommendations may be

suitably incorporated and reiterated in the 3rd Report.

(vii) Final report be readied and letter to the Secretary to Hon'ble President for seeking date and time convenient to Hon'ble President for presenting the 3rd Report by the Commission sent by end of February, 2010.

3. The Commission considered and endorsed the course of action suggested by the Secretary, National Commission for Scheduled Tribes.

Additional Agenda Item.

Agenda Progress regarding preparation of 4th Report of the National Commission Item II for Scheduled Tribes for the period 2008-09

The Secretary, National Commission for Scheduled Tribes informed the Commission that the preparations for drafting of Chapters of 4th Report of the Commission have already been initiated. The following observations were made during the discussion:

(i) First Draft of all the Chapters may be put up to Secretary before the end of the month so that these drafts could be circulated after these have been screened by the Secretary

(ii) Chapter on Development Planning

Information relating to implementation of Tribal Sub-Plan in various States/ UTs and Central Ministries/ Departments has been called and it may take some more time to collect the same. In the meanwhile, data available with the Planning Commission in the context of Mid-Term-Appraisal may be obtained and after suitably incorporating the same the draft Chapter may be prepared.

(iii) Chapter on Service Safeguards

The draft Chapter does not clarify the Minority status of Aligarh Muslim University and Jamia Milia Islamia. The position may be got confirmed in writing from both the Universities; and in case the Universities do not respond, a meeting with the Vice-Chancellors of both the Universities may be called in the Commission. A proper agenda note about the issues to be discussed in the meeting be prepared in advance before seeking a date for the meeting.

(iv) Chapter on Forest Rights

Information available in the Commission may be compiled and issues may be drawn from the data and thereafter draft Chapter may be submitted to Secretary for screening and comments next week so that the draft Chapter is circulated to the Members by end of February, 2010.

(v) Chapter on Relief & Rehabilitation

Material for Draft Chapter on R&R has been seen by Secretary. The draft

Chapter may be submitted to Secretary next week so that the draft may be

circulated among Members at the earliest

(vi) Chapter on Caste Certificates

Draft Chapter has already been circulated. Information regarding functioning of

Screening Committees in various States was called by the Commission. Since a

number of responses have been received, the same may be compiled and

incorporated into the draft Chapter.

(vii) Chapter on Atrocities

Draft Chapter has been prepared. Certain information relating to atrocity cases

dealt in the Commission is being compiled by each RU in a prescribed format.

Similar information also needs to be called from the Regional Offices.

(viii) Chapter relating to Case Studies (Successful Cases)

Draft material of the Chapter may be circulated to all RUs for checking the brief

in respect of each case and to ensure that no successful case relating to 2008-

09 is left out from inclusion.

(ix) Chapter relating to Policy matters

The draft Chapter has already been circulated and the replies awaited from the

Ministries/ Departments on some of the issues will be added as soon as received

4. The Commission noted the above observations and desired that the draft of the 4th

Report may be submitted to the Commission by end of March, 2010.

5. The Secretary informed that the Commission had not met for some time and,

therefore, a meeting may be called soon to consider issues pending for consideration by the

Commission. The Vice-Chairman, NCST approved 22nd February, 2010 as the date for the

next meeting and directed that the Agenda for discussion may be submitted to him for
