

Meeting with District Collector and other Senior Officers, Godhara, Panchmahal

Hon'ble Member held a meeting with the District Collector, DDO , DSP and other senior officer of Godhara, Panchmahal. Hon'ble Member received a warm welcome by the Collector and other officers. Following are some issues discussed during the meeting.

Employment:

Hon'ble Member suggested to create more employment opportunity through productivity enhancement in agriculture, agriculture based animal husbandry and dairy based activities could be increased to create more employment for tribals in the area. To create more employment opportunities for tribals, it is also important to upgrade the level of overall education and professional training programmes for the tribal youth. After training make a data bank to provide placement for the tribal youth. Hon'ble Member also suggested opening more coaching or study centre for the tribal students to prepare them for competitive examination. Hostel facilitates should also be provided in these centers.

Health:

Hon'ble Member desired to know about the availability of doctors and medical staff in the hospitals in the district. It was informed that there is health scenario in the tribal areas of the District was generally satisfactory. There is a shortage of availability of lady doctors in the hospitals. Hon'ble Member suggested arranging special medical programmes for the tribals time to time to spread medical awareness among them. State Govt. may also provide the Ayurvedic Treatment facilities to tribals.

Hon'ble Member welcomed by the District Collector and other senior officer at Lunawada, Mahisagar. District Collector, DDO, DSP and other Senior officers were also present in the meeting.

Hon'ble Member also suggested constituting a monitoring team in the District to review the above schemes for further improvement in the education quality among the tribals.
